

# International Common Standards for Gendai Reiki Masters

## Gendai Reiki Healing Association

Revised on and effective as of March 1, 2021

The International Common Standards for Gendai Reiki Masters have been set forth by Hiroshi Doi, the representative of Gendai Reiki Healing Association (GRHA), to maintain good morals, dignity, and ethics of Gendai Reiki masters.

1. All Gendai Reiki Masters must abide by the regulations listed below.

- Gendai Reiki Official Manuals

- (1) The official manuals are available in Japanese, English, and Spanish, and the contents are identical in all languages. The official Japanese manuals were completed in 2012 and have been revised to the current version. The official English and Spanish manuals have been revised in 2020. As proof that Reiki originated in Japan, the covers of the manuals feature the Japanese crest, representing the nation of Japan.
- (2) All Gendai Reiki Masters must purchase the official manuals from GRHA authorized distributors.
- (3) All Gendai Reiki Masters must use the latest official manuals. The GRHA authorized distributors always distribute the latest manuals.
- (4) The official manuals can only be purchased by Gendai Reiki Masters who have completed the correct in-person Gendai Reiki seminars using the official manuals.
- (5) A seminar conducted using unauthorized materials (falsified manuals or materials other than the official manuals) is not recognized as a legitimate Gendai Reiki seminar. If you have learned at such a seminar, you are not certified as a Gendai Reiki master or a practitioner<sup>1</sup>.
- (6) A Gendai Reiki Master who is using the older manuals must switch to the latest official manuals immediately. If you continue using the older manuals even after reading this International Common Standards for Gendai Reiki Masters, you are prohibited from using the names “Gendai Reiki Ho”, “Gendai Reiki”, “現代靈氣”, “現代靈氣法”, “現代レイキ”, and “現代レイキ法”.
- (7) Copying and altering the official manuals are strictly prohibited.
- (8) Giving, showing, and disclosing the official manuals are strictly prohibited.
- (9) Introduction and Level I build an important foundation of Gendai Reiki Ho for beginners. These two official manuals must be purchased and taught together for a better understanding of Gendai Reiki Ho.
- (10) A Gendai Reiki Master must submit a copy of his/her master certificate, training lineage, and signed Promissory Note to a distributor when purchasing the official manual for the first time.
- (11) Translation of the official manuals:
  - Unauthorized translation of the official manuals is strictly prohibited.
  - If you are interested in translating the official manuals into your language, please contact the GRHA. After signing the translation contract with Hiroshi Doi, you can start translating.

- Gendai Reiki Ho Seminars


- (1) A Gendai Reiki Master must use the latest official manuals when offering a seminar. A seminar conducted using unauthorized materials is not recognized as a Gendai Reiki seminar. If a lineage includes a master who teaches using unauthorized materials, that person and all subsequent trainees are not certified as Gendai Reiki Masters<sup>2</sup>.
- (2) A distant seminar and distant attunement are strictly prohibited. A person who received distant attunements is not certified as Gendai Reiki Master or a practitioner. If a lineage includes a master who gives distant attunements, that person and all subsequent trainees are not certified as Gendai Reiki Masters. In the original Japanese Usui Reiki, Reiki begins with a hand-placement treatment with the goal of reaching Anshin Ritsumeiki through spiritual enhancement. Distant attunements do not belong to Mikao Usui Sensei's philosophy. We must pass down the pure Reiki energy with Usui Sensei's philosophy correctly; therefore, Gendai Reiki Ho does not permit distant attunements.
- (3) Do not change the Gendai Reiki Ho Attunement methods. Each Gendai Reiki Ho Attunement contains philosophy and conscious vibrations of Mikao Usui Sensei. Adding any other philosophy and symbol from different Reiki systems diminishes the purity of the energy. Pay special attention to the first attunement in Level I since it will build an important foundation for a trainee's spiritual development in the advanced levels.
- (4) The Gendai Reiki Ho attunement and Reiju methods must be taught only to your Level IV trainees with all the necessary information written in the Level IV official manual during a face-to-face seminar.
- (5) The Gendai Reiki Ho Symbols must not be disclosed or shown to those who have not attained the appropriate levels.
- (6) A Gendai Reiki Master must give a certificate and a correct training lineage in writing to your trainee after your seminar. The certificate must state that Gendai Reiki Ho has been taught to the trainee. The energy lineage must begin with Mikao Usui Sensei and list all the masters to your trainee correctly.
- (7) Avoid listing "Gendai Reiki Master" and "Usui Reiki Master" together, as it may lead to a misunderstanding that Gendai Reiki Ho and Usui Reiki Ryoho are different.

- A name of a Gendai Reiki Ho school or a group

A Gendai Reiki Master may decide a school or a group name at his/her discretion. If a Gendai Reiki Master group or an individual chooses to bear the name of a region or country, they must obtain the consent of all Gendai Reiki Masters and groups in that region or country. Please discuss the matter in good faith, avoiding friction and conflict.

2. The International Common Standards for Gendai Reiki Masters shall be revised as needed.

1, 2: Those who have completed Level IV Gokuikaiden using the supplementary materials in Portuguese, Chinese, and Taiwanese are certified as Gendai Reiki Masters. This is a temporary measure until the official manual is completed. Once the official manual is completed, the International Common Standards will apply.
